- **18.** If you want to tell us something about your experience with the online education, please do so. (answered by 37 persons)

- **20.** What aspects of this course should be changed or added to? Give reasons and suggestions. (answered by 32 persons)
 - For the first time of my studies in Maastricht, there is absolutely nothing that should be changed in this course.

 - I, personally, believe the negotiation strategy should be worth more than the actual negotiation. In the strategy, one can show that they really went into the subject matter and into all legal articles, while you may not need all articles in the negotiation. My group was able to reach an agreement that was way more beneficial than everything we ever hoped for, but were then critized for not using all articles... I kind of understand that, however, in the negotiation strategy we showed that we were prepared to use all articles and the fact that we did not need them and still reached such a great agreement should not be a negative point, in my opinion.
 - I wish more courses at the faculty were like this one. I don't even need to see my final grade result, that doesn't matter to me as much as how much I enjoyed working in this course, and I don't think that has ever really happened before in 3 years of study.
 - There is honestly nothing major I could think of that should be changed, but maybe if I am being very nitpicky then I would perhaps suggest changing the requirements for the written submission for the negotiation plan from a max page count to a max word count? We struggled a bit trying to fit all the text on two pages but we were not sure as to whether we could reasonably change the font size or the margins, so we thought maybe a max word count would be more clear for everyone:) Very minor detail though, this was overall a very great course!

part in the week 5 presentations, so, yes, everything was greatly put together.

- Put a disclaimer in the course description NOT to take taxation in the same period as this (I know this isn't possible). I just wish I was able to focus fully on this course and not be completely overwhelmed and drowning in taxation work. It was just so lovely reading all the optional materials and I wish I've had the time to do more research on the topic.
- Right now I do not have any suggestions on how to make this course even better.

- For the negotiations, while I understand that the tutorials have a number of people, which would not make smaller groups an easy feat, I would have preferred to work with less people. It was surprisingly easy to coordinate our work/meetings, however, some members of the team pulled their weight more than others. And especially for the presentation portion, being paired with less members would make the grading more fair, otherwise it is possible that one would have to concede to getting a lower grade than what they believe they could have done, which is mildly disappointing.
- Honestly cannot think of anything:/
- · Nothing should be changed
- I might say that maybe the lecture shall be taken on a different day from one of the other courses. Furthermore, it might be helpful also a final recap before the memo. It might be also useful for the preparation of the memorandum to ask students to resolve a case during the tutorials in this way and then discuss them on the tutorial with feedbacks.
- Nothing, the course was well set up.
- The negotiation part was fantastic and I would suggest to add some optional reading on "how to negotiate" so the negotiations have more professional touch than just some students screaming their demands without realistic expectations.
- Granting the possibility (within each tutorial) to pick the members of the group for the negotiation, and if a group cannot be formed, then the turo may fill the spots. otherwise the chance of receiving a lower grade / produce a non-satisfactory work due to the rest of the group is high.
- It might not seem very creative, but generally speaking, this course was perfect the way it was, I would not change very much.
- nothing should be changed.
- Overall great content however I feel as the lectures are quite superficial compared to the readings: perhaps the lecture could cover slightly different aspects because all content for the week is comprehensively covered in the reader
- Both assessment methods were something we did for the first time in the whole degree, so a little more guidance on the methods would have been welcome.
- Sometimes I couldn't really find the relevance of a learning a given topic or why some topics were discussed only extremely superficially. I don't think that the assessment methods were clear, especially for the negotiation it was very vague what was expected pf the students. I understand the point of giving us leeway in the negotiation, but some pointers on what and how we would be graded would have been very helpful.
- I would decrease the number of optional readings and increase the number of mandatory readings. I would keep the reader but make the most important (journal) articles as mandatory reading as well. In this way there would be more reading but it would be clearer what we are definitely expected to know.
 - And in case this is not desirable, I would maybe extend the reader a bit so it goes into more depth.
- I think the only change that could be made is that the lecture and the readings could be less coherent. I felt like the lecture sometimes just exactly repeated the readings. It could be interesting to go a bit more into detail on some things or just explore different aspects of IBL that are interesting to students, as we did in the Week 5 Tutorial.
- More discussion about the case law, because they might be really helpful with the tutorial tasks and the memorandum, but we haven't talked about it a lot.
